



Town Manager's Report for September 24 – 30, 2018

Items to report on from this week include the following:

Planning/ Building/ Engineering Update:

The **Public Works Director** conducted interviews for the vacant senior/ associate engineer positions.

The following project was continued from September 25 to the October 9 Site Development hearing:

- Landscape screening plans for a new residence under construction at **26890 Alejandro Drive**. Two neighbors were in attendance and commented on proposed landscape screening. The application was continued to allow staff to review Environmental Design and Protection Committee concerns regarding grading.

The following projects were approved at the September 25 Fast Track hearing:

- A new residence with basement on property at **26880 Ortega Drive**. No neighbors were in attendance. A condition was added requiring dedication of an open space easement over a portion of Barron Creek that is on the property (from the property line to 25 feet from top of bank).
- An addition and remodel project on property at **27240 Natoma Road**. One neighbor was in attendance and had concerns about storm water run-off. A grading and drainage plan (that was reviewed for compliance with Town and NPDES requirements has been reviewed by Engineering) was approved as part of the development plans.
