

Town Manager's Report for March 2-6, 2020

Items to report on from this week include the following:

Public Works Engineering and Maintenance:

- Staff has prepared the pathway layout for submittal to the City of Los Altos.
- Staff has engaged with a surveyor for the Altamont Plunge pathway and survey work was completed on February 21, 2020.
- Staff has received three (3) quotes for survey services for La Paloma to Robleda pathway and will be receiving a third quote by February 21, 2020. An agreement has been prepared with a tentative start date of March 23, 2020.
- Staff has prepared the agreement for the Estacada 2B path construction.
- Staff is continuing construction site inspections in compliance with the Town's Stormwater Permit.
- Staff attended the CPUC Rule 20 Rulemaking Change Hearing on March 3, 2020.
- Staff met with California Water to discuss the upcoming CIP projects within the Town boundaries.

Planning/ Building:

Monthly Building Dept Update

For the second month in a row, Building staff saw a significant increase in building permit activity as compared to a year ago (January 2018).

March 5, 2020 - Planning Commission Meeting

• Zoning Code Amendments

The Planning Commission reviewed an ordinance to amend Title 10 of the Town of Los Altos Hills Municipal Code (Zoning and Site Development) to adopt updated regulations for the placement and development of Accessory Dwelling Units, and forwarded the ordinance to the City Council with a recommendation to adopt the ordinance with the following changes: 1) Limit detached ADUs to one-story; 2) do not allow basements under detached ADUs located with 30 feet of a property line; and 3) include "general public easements" in the example list of easements that ADUs must stay outside of. Two members of the public provided comments.

The Planning Commission also made a separate motion that recommended that the City Council consider amending the Town's Maximum Floor Area (MFA) requirements in the Zoning Code to include a reserved allotment for future ADUs in order to maintain the existing floor area maximum while also accommodating ADUs as required under State law.

The Planning Commission reviewed a Site Development Permit for landscape screening, driveway gate, and fencing for an approved new residence, and approved the permit with additional conditions related to trees species and locations and minimizing grading. One member of the public provided comments on the project.
