1. Twin Oaks Court (APNs 182-02-17, 182-02-018, 182-02-019, 182-02-020, 182-02-021, and 182-02-022) – File #TM26-0003 – Lands of Draco Nest LLC

A meeting of the Subdivision Committee pursuant to Sections 9-1.202, 9-1.506 and 9-1.507 of the Los Altos Hills Municipal Code to gather preliminary information and receive public comments regarding a request for a Tentative Map proposing the subdivision of six existing parcels, totaling approximately 11.9 acres, into a total of 311 residential lots. Lots 4-6 (APNs 182-02-020, 182-02-021, 182-02-022) on the property is zoned MF (Multi-Family Residential) and Lots 1-3 (APNs 182-02-017, 182-02-018, 182-02-019) on the property is zoned RA (Residential-Agriculture). The tentative map application is incomplete at this time.

The Subdivision Committee will receive a project introduction from staff, ask clarifying questions on technical aspects of the tentative map if any, and receive comments or questions from affected public agencies, public utilities, and members of the public in attendance, if any. This meeting is informational only and no decisions will be made at the meeting.
