SCHOOL DISTRICT REORGANIZATION PETITION

Our Town has embarked on an effort to create a new elementary school district, which will be available to all of our children in grades K through 8. Our children will be able to attend elementary school in town, with their neighbors, and we will strengthen the sense of community for all. (See Map in Insert - currently no public school in Town boundaries.)

Specifically the petition calls for the creation of a new K-8 school district covering all of the Hills. This district would control the remaining school sites in Town. This district would have its own elected school board, which would have as its sole mission the education of our public school children through the 8th grade. As such, we would be on par with Woodside (population: 5,350) and Portola Valley (population: 4,400), both of which are smaller than Los Altos Hills (population 7,900) and both of which have their own neighborhood elementary school.

We anticipate that students currently in school at the time reorganization ballot passes at the polls will have the option of being "grandfathered in" to continue attendance at their current elementary schools. That is a standard practice under the State code (law) that defines the reorganization process.

The petition further calls for our high school students to remain in the attendance areas of Gunn High School (PAUSD) and Los Altos or Mountain View High Schools (MVLA), effectively using the current attendance boundaries.

PAUSD, in a letter to LAH residents, suggests that reorganizing is some kind of Pandora's Box where virtually anything can happen. Actually the process is governed by the California Education Code; and only those solutions will be implemented that are supported by law, waiver, and/or special legislation the County/State, and, ultimately, LAH voters. None of you have to worry about losing access to Gunn in this process.

NEXT STEPS

The petition goes first to the SCCOE (Santa Clara County Office of Education) where it is assigned to a special committee that deals with reorganization requests, the County Committee for School District Organization ("County Committee"). We expect some back-and-forth activity as the County Committee does its work.

First, the County must determine whether the petition has merit and due consideration. The County has indicated a hearing on this matter will occur on December 7, 2006.

Second, the County staff and Committee must study the reorganization options and make a substantive decision.

Third, there is an opportunity to appeal to the State Board of Education to adopt or reject the plan.

Finally, the voters of Los Altos Hills must approve any proposed reorganization through an election. The County Superintendent, Dr. Colleen Wilcox has estimated the reorganization process could take anywhere from 18 months to 4 years. (See Flow Chart in Insert.)

During this time voters in our Town will be given many opportunities to hear from your City Council on the progress of the petition and to give us input at our City Council meetings.

ACTING CITY MANAGER'S REPORT

Dear Residents:

After completing an extensive executive search utilizing the services of a professional recruitment firm, the City Council has appointed me to serve as your City Manager. The position is an awesome responsibility and I am honored to be selected. The Town staff and I will continue to do our best to efficiently deliver municipal services to you the residents.

Senior Planner Debbie Pedro, who has been with the Town for four years, has been appointed to serve as the Town's Planning and Building Director. Debbie has a Bachelors degree in architecture from UC Berkeley and a Master's degree in urban planning from San Jose State. She is also an AICP certified planner. All of us here are looking forward to working with Debbie in her new position.

The City Council continued a longstanding Town tradition of fiscal prudence by closing out the previous fiscal year with a small budget surplus and adopting an overall 11 million dollar budget for this coming fiscal year. See Town Finance Director's Sarah Ragsdale's report in this newsletter for more detail on the Town's revenue picture and on how your tax dollars are assiduously put to work.

This past quarter the City Council awarded contracts totaling \$1.08 million dollars for Town street improvements. These improvements include the El Monte Road and Page Mill Road street rehab program (\$652K) and the annual street resurfacing and street improvement program (\$430K). The El Monte Road street rehab project encompasses that section of roadway between Stonebrook Drive and Moody Road. The Page Mill Road project encompasses roadway segments between Berry Hill Lane and Country Way, and between Matadero Creek Lane up to the Town boundary north of Altamont Road. The annual street resurfacing and street improvement program includes various public streets that were identified for improvement by the Town's Pavement Management System program. These major capital projects are scheduled to get underway in September. If you would like more information on the Town's street improvement program, please contact City Engineer Henry Louie hlouie@losaltoshills.ca.gov Also under construction at this time is the .25 mile Segment 1A of the El Monte Avenue/ Moody Road Pathway project. This is the first of three pathway segments that will ultimately provide a safer pedestrian connection between Foothill College parking areas and the Duve-neck Windmill Trailhead off of Rhus Ridge Road.

As of February 2006, it is against State law for residents to dispose of "Universal Waste" in their common trash receptacles. Universal wastes are hazardous wastes that are generated by a wide variety of people every day. Universal waste may not be discarded in solid waste landfills. Scientists at the California Department of Toxic Substances Control (DTSC) have found that these wastes will leak toxic substances, mostly metals, in a typical landfill. Some examples of universal waste include: fluorescent

lights, household batteries and certain types of electronic waste (televisions, computer monitors and related computer peripherals). The City Council responded quickly to this new law by adopting a Los Altos Garbage Company proposal to host twice-annual universal waste collection events concurrent with the existing yard waste collection program at Foothill College. The next collection event is scheduled for October 28th. The Council also approved a LAGCo proposal to expand curbside recycling services by accepting most types of household type batteries. Residents may place their spent batteries in clear plastic ziplock bags and place the bags next to their recycling container for collection. No increase in garbage rates for these new services is proposed at this time.

LOS ALTOS HILLS COUNTY FIRE DISTRICT

Expansion of Brush Chipping Program

The LAH County Fire District is expanding the brush-chipping program from once per year to twice per year. Next year, the brush chipping will take place in January '07 and July '07.

Residents will receive a letter regarding the first new program in December '06 with chipping scheduled for January '07. (Starting: 1/1/07 thru 6/30/07)

The second program will be repeated again in June '07 with chipping in July '07. (Starting: 7/1/07 thru 12/31/07)

Be prepared to receive a letter with a card to return requesting chipping in December 2006. Chipping appointments will be made by the contractor for January 2007.

The chipping program is very successful and meets the need to reduce potentially dangerous fuel from brush and tree branches.

PLANNING DIRECTOR'S REPORT

I am very honored and thrilled to begin my new position as the Planning Director. Over the last few months, we have completed a number of significant projects:

INCENTIVES FOR SOLAR PANELS - For those of you thinking about installing a photovoltaic system for your home, the Council has recently adopted several ordinances to promote energy conservation through the use of solar panels.

- Free Building Permits (Reso. 1-06) - Building permit fees are waived for the construction or installation of solar energy generation equipment.
- Development Area Exemption (Ord. 446) - If you install a ground mounted photovoltaic system, up to 500 sq. ft. of the solar panels may be exempt from development area calculations.
- Development Area Bonus (Ord. 500) - If you install a roof mounted solar system, you may qualify for up to 500 sq. ft. of bonus development area.

IMPROVED WIRELESS COVERAGE AT TOWN HALL - As you walk or drive by Town Hall, you may have noticed a new "tree" that has sprung up next to the Heritage House. The wireless communications facility consists of Cingular's wireless panel antennas as well as the Town's emergency communications antennas. The 70' tall tower is disguised as a pine tree to help it blend in with the surrounding environment and will improve the cell coverage for Cingular customers within an approximately 3/4 mile radius.

EUCALYPTUS TREE ORDINANCE - The City Council has just adopted an ordinance requiring removal of eucalyptus trees that are within 150' of any structures or roadways. The ordinance will apply to additions or remodel totaling 1,200 sq. ft. or more. Eucalyptus trees are invasive, non-native trees that are potential fire hazards. In addition, the shallow root structures of these tall trees make them unsuitable around the vicinity of structures or roadways. The following six species of eucalyptus are known for their propensity to drop limbs and susceptible to pest attacks and are subject to removal at the time of site development approval:

1. Blue Gum (E. globulus)
2. Pink Ironbark (E. sideroxylon rosea)
3. River Red Gum (E. camaldulensis)
4. Swamp Gum (E. rudis)
5. Honey Gum (E. melliodora)
6. Manna Gum (E. viminalis)

MORE AMBIGUOUS TERMINOLOGY (HIGHLY VISIBLE LOTS) REMOVED FROM TOWN CODES - At their July 27th meeting, the City Council determined that "highly visible lots", as currently referenced in Section 10-2.702 of the Town Site Development Ordinance, could not be accurately defined. The Council ordered the ambiguous reference to be removed from the Code. No new or additional restrictions on homes were approved.

Looking ahead, our department has a number of significant long range projects on the agenda, including the comprehensive General Plan update, and several ordinance amendments. Additionally, our staff will continue our commitment to provide efficient and effective services to applicants and residents in the development permit process.

NEW WESTWIND COMMUNITY BARN COMMITTEE APPOINTED

A new 11-member standing committee of the Town has been formed to "serve as an advisory body to the Council on matters related to Westwind Community Barn" and to "assist in the planning, development, and implementation of a Master Plan for the facility and associated space."

The Committee will also make recommendations to Council for funding sources (i.e. State Park Bond monies and privately-raised monies from the Supporters of Westwind Community Barn) for the renovation and restoration of the Barn.

Current programs at Westwind, such as boarding, 4-H Riding for the Handicapped, Pacific Ridge Pony Club, and Parks & Recreation year-round riding classes, will remain in place. Consideration may be given to expanding riding opportunities to residents who do not own horses. One such opportunity might be a trail-riding program, which takes advantage of Westwind's proximity to off-road pathways and open space.

Open Space Committee Report

LAH RESIDENTS HELPING WITH WILDLIFE STUDY

The LAH Open Space Committee's Wildlife Subcommittee is meeting with some of the many wildlife survey respondents who volunteered to help describe the habits and movement of wildlife in their neighborhoods. These LAH residents are providing information that will be useful in understanding how deer, fox, bobcats, and other animals move about the town.

Wildlife move throughout our Town along already existing natural passageways, particularly in riparian areas (streams, creeks, and drainage areas) which provide food sources, shelter and passage for many different species. Most corridors are found in already protected Open Space Conservation Areas. But identifying the most important of these is key to understanding which are the most valuable natural passageways.

One of the goals of the Wildlife Study is to enable Town planners to rely on credible expert analysis and to enable developers and homeowners to know in advance which areas are sensitive.

In furtherance of the goal of preserving a rural environment, the Town's General Plan calls for "protecting and maintaining those areas necessary to the integrity of natural resources . . . with special emphasis on . . . open spaces for wildlife habitat."

Maintaining natural corridors will help keep animals healthy and wild (and off the roadways), while minimizing contact with humans, allowing them to continue living among us in as natural a state as possible.

ADOBE CREEK COLLABORATIVE

Progress on Adobe Creek Reach 5

For nearly three years now, work has been progressing by an informal collaborative organization to achieve consensus on a design for the future of this stretch of Adobe Creek just downstream of Edith Avenue. The collaborative is composed of representatives from the Santa Clara Valley Water District, creekside residents of both Los Altos Hills and Los Altos, town representatives from both towns, as well as four government agencies from whom permits will be required. Tentative agreement has now been reached on a conceptual design for the future of this part of the creek.

Known as Alternative 8, the design is intended to correct or control erosion and flooding problems and enhance the environment in a manner that is acceptable to all the stakeholders. Improvements are scheduled to be constructed in 2008 if no more serious hurdles are encountered during detailed design and the government funding is forthcoming. IN MEMORIAM

GENTLEMAN OF THE TOWN

It is with a sense of great loss that we report that Dan Alexander passed away on Thursday, November 9th. Dan had been in ill health for a few years. But in spite of his infirmities he still volunteered faithfully - serving on the Community Relations Committee and Friends of Westwind Board until his poor health precluded him from attending.

At the time of his death he was living with his son & daughter in law, Dan & Genie Alexander.

Dan was raised in Salt Lake City, attended the New Mexico Military Academy, and graduated with a commission in the Horse Cavalry in 1937. Later, while at Stanford University, Dan met his future wife Peg and they were married.

During World War II he served in the Army Air Corps. One memorable assignment during those years was the devising of a plan to get Allied POW's out of German prison camps, quickly and safely. About forty prisoners were neatly tucked into what was formerly a bomb bay. Lt. Colonel Dan brought the plan to Eisenhower's staff and it was approved. Close to 300,000 soldiers were successfully retrieved, and Dan was awarded a Bronze Star for his part in the rescue.

Dan worked for PG&E from 1939 until his retirement in 1981. He was the manager of the Mountain View office for his last 12 years. Although living in the Hills, the Mountain View Chamber of Commerce elected him the Citizen of the Year in 1980. Someone remarked that Dan was living in one town and being honored by another. At the time Dan commented, with his characteristic humility, "I just try to be a good citizen in Mountain View because that is where my business is."

Dan loved sailing his day sailor, often competing in the races at Huntington Lake. He was also a skier, horseman, gardener and historian. He traveled the world over including the Silk Road in China. Dan was a member and past president of Mountain View's United Way Board of Directors, Rotary International, the Chamber of Commerce, the Los Altos Hills Community Relations Committee, Los Altos Tomorrow, a community foundation serving both Los Altos and Los Altos Hills which focuses on improving the quality of life for citizens, President of the Friends of Westwind, and was an elected member of the Purissima Hills Water District since 1971, serving as its President in the 1980's. Dan also served on the "Save the Griffin House" Committee, the Los Altos Hills Historical Society and the Los Altos Hills Horsemen's Association. In 2005 he was appointed a Fire Commissioner to the Los Altos Hills County Fire District. Whenever you traveled on Elena Road, you often would see Dan on horseback with one or more of his grandchildren. Sometimes he would be carrying a basket of his homegrown tomatoes to share with the neighbors. He was a beloved neighbor.

His wife, Peg, preceded Dan in death.

A memorial service "A Celebration of Dan's Life" will be on Dec. 17, 2006 2 PM at The Crowne Plaza Hotel, 4290 El Camino Real, Palo Alto. New Emergency Services Workshops to be offered to Residents

The Los Altos Hills County Fire District will be offering Personal Emergency Preparedness (PEP) Workshops starting in early 2007. The District in partnership with the County Fire Department recently created a new Emergency Services Coordinator position to address the needs for emergency preparation for our residents of the Town and the unincorporated area. The new coordinator is firefighter Michael Sanders, who has over 25 years experience in the department as a firefighter captain and educator. Mike's primary goal is to offer 10 Personal Emergency Preparedness (PEP) workshops and 6 Senior PEP workshops and eventually a CERT program. PEP classes will be 3-4 hour courses and will emphasize the special needs of hills homeowners and as well as seniors. Mike will launch the first workshops in early 2007.

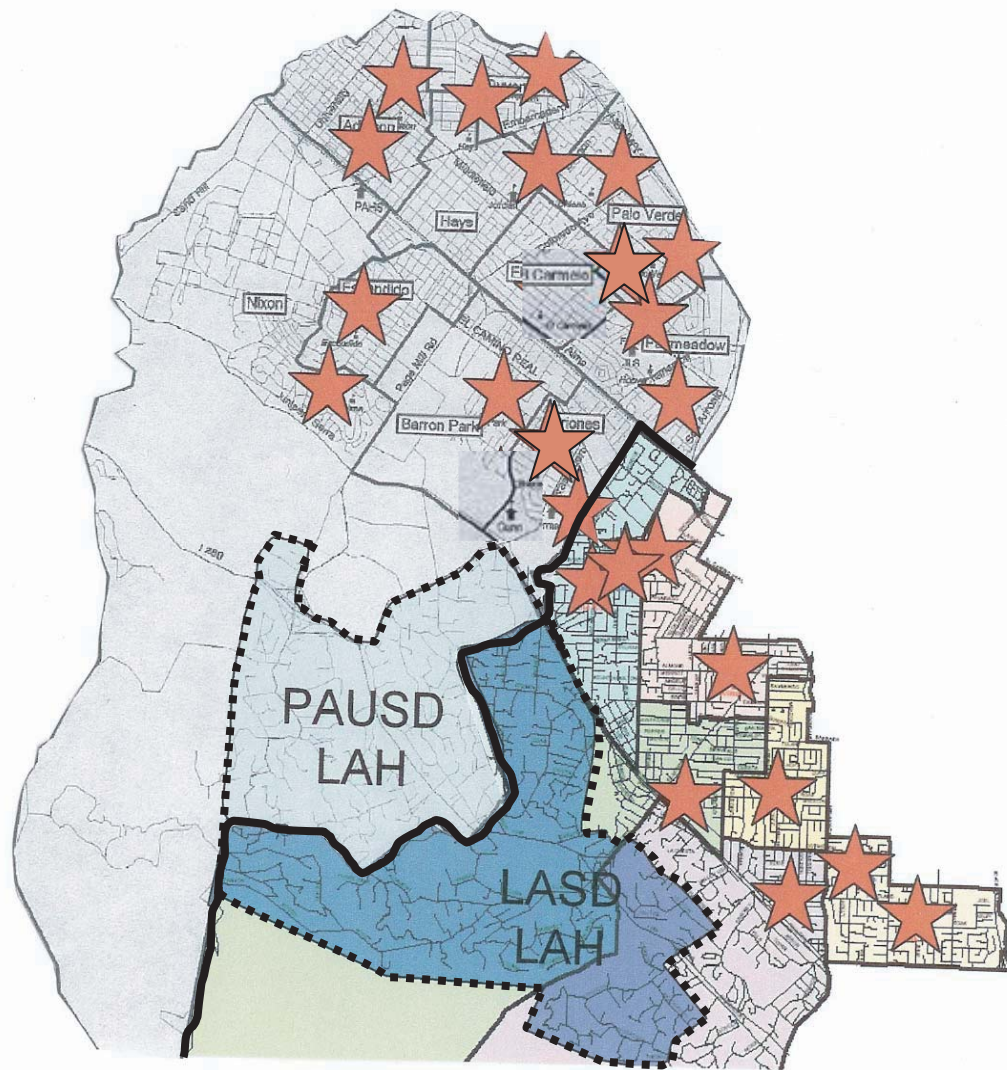
