A few items to report on this week:

1. The **Sheriff's Report** is attached. An application for a fireworks display permit at 13310 La Paloma Road tonight was disapproved by the Fire Department (see attached). The Sheriff's office has been notified.

PLAN REVIEW COMMENTS

Review of plans and materials inventory to conduct a fireworks display at an existing residential property at midnight of New Year's Eve, December 31, 2014.

Plans reviewed for compliance with the Los Altos Hill Municipal Code (LAHMC) and the California Health and Safety Code (CH&SC)

1. Los Altos Hills Municipal Code Section 4-2.110 (Fireworks) requires the application for permits for public displays shall be made in writing at least fifteen (15) days in advance of the date of the display. [LAHMC Section 4-2.110]

2. The California Health and Safety Code requires applications for firework permits to be made in writing at least ten (10) days prior to the proposed act. [CH&SC Code Section 12643]

One purpose for the fifteen day advance notice is to allow for the proper investigation of the application, including potential concerns from Los Altos Hills Town staff and from law enforcement agencies serving the area, including the Santa Clara County Sheriff's Office, the Los Altos Police Department and the California Highway Patrol. As this permit application does not allow for adequate time to fully investigate the permit application, the permit application is disapproved.
